Terms of Reference:

- The supplier shall deliver and supply purified/mineral drinking water to the university for one (1) year period;
- A purified/mineral drinking water contained of 5 gals. per container with a unit cost per container of ₱ _____;
- Every purchase of 10 containers, the supplier shall give additional one (1) for free (10+1), refilled purified/mineral drinking water;
- The supplier shall lend hot and cold water dispenser, including new/acceptable five gallons containers and outright replace the old/unacceptable empty containers to the university;
- The supplier shall present a potability test result to the university on a semi-annual basis;
- The university shall pay the supplier monthly in the amount stated in the billing statement;
- The Agreement shall be renewable every year at the option of NwSSU;
- Payment shall be made in Calbayog City.

Deadline for submission of proposal shall be on or before February 8, 2021 @ 1:00 PM and the Opening will be February 8, 2021 @ 4:00 PM at the Office of the BAC Secretariat, NwSSU-Main Campus, Calbayog City.
